## Acknowledgement of Risk, Release and Indemnity

This Acknowledgement of Risk, Release of Liability and Indemnity ("Release") is made by the undersigned for the benefit of **Elings Park Foundation and Elings Park International Raceway**, its officers, directors, agents and employees (excluding the undersigned if an employee), and the heirs, personal representatives, successors and assigns of each of them (collectively, the "Releasees").
